Reducing School Absenteeism

Lack of proper hygiene can affect students' physical health, mental well-being, confidence, self-esteem and focus. This can lead to their being bullied and even absenteeism. With more than half of students in Shelby County Schools being considered economically disadvantaged, living in households with incomes less than 200% of the federal poverty level, this has become a rising issue.

Through a \$90,000 grant from UnitedHealthcare's Empowering Health initiative, the Shelby County Education Foundation and UnitedHealthcare are helping to address this issue by providing full-size hygiene and personal care products to the students at Kate Bond Middle School. On August 16, both organizations dropped off shampoo, deodorant, soap, toothbrushes, toothpaste, dental floss and feminine hygiene products for the students. School nurses, staff and administrators will help identify children in need and distribute the hygiene supplies accordingly.

Helping Build Healthier Communities

UnitedHealthcare employees volunteered at The Little Pantry That Could on August 16. During this time, they assisted in sorting produce, preparing 168 bags of shelf-stable food, and stocking the shelves for the pantry opening on August 17.

The Little Pantry That Could is a 501(c)(3) organization that serves fresh produce, shelf-stable food, and offers a variety of other assistance such as clothing, shoes, sleeping bags, counseling, resume writing assistance and much more. Serving the Middle Tennessee area, they are not bound by county borders and feed approximately 200-250 families a week, some traveling from 50-100 miles away. They also do a significant amount of Homeless Outreach by setting up camps, serving as advocates and connecting individuals with much-needed services. Their motto is simple, "If you are hungry, we will feed you."



Community Health and Information

UnitedHealthcare—alongside the Memphis Police Department, Public Works, Shelby County Sheriff's Department, Neighborhood Watch and AARP of Tennessee participated in a community health and information meeting sponsored by City of Memphis Councilwoman Gerre Currie. At the event, UnitedHealthcare representatives provided information about our Dual Special Needs Plans and programs, EPSDT screenings, and the importance of preventive primary care visits.
